#### **Dear Doctor Permut;**

I am writing you with regards to Doctor Jeremy Conklin, who recently applied to become a fellow in your Congenital Cardiac Surgery program. It was recently brought to my attention that you may be attempting to discriminate against this board certified physician based on his credentials as an osteopathic trained surgeon. In your letter to Doctor Conklin declining his application, you cited that "certification or eligibility for certification by the American Board of Thoracic Surgery" as a prerequisite for consideration. This is a criteria established by the program and not in statute nor in the certification of your program.

During my tenure in the Washington State Legislature, I was deeply concerned with the discrimination practices by certain hospital organizations within our state and by the University Of Washington School Of Medicine towards osteopathic trained and board certified physicians. Thus, I worked closely with the late Doctor John Coombs, a colleague, friend, and Assistant Dean at the University Of Washington School Of Medicine to draft and enact into law RCW 70.41.235. That law clearly states that it is illegal to discriminate against physicians who have earned the Doctor of Osteopathic Medicine and Surgery. Furthermore, discrimination based on board certification is prohibited. It appears your intent to exclude physicians from participating in your program is based on credentials and not academics, thus, keeping it pure allopathic — i.e. MD. Therefore, I must caution you that you are in violation with the spirit and intent of this law. By enacting this legislation, it was clearly my intention to preclude such actions that you are currently practicing within your program.

In preparing this correspondence I took the opportunity to obtain a copy of the eligibility requirements for candidates applying to an ACGME Congenital Cardiac Surgery program. In your correspondence to Dr. Conklin, you referenced criteria that were in effect on June 30, 2013. However, you did not mention that those criteria had changed with new eligibility criteria that became effective on July 1, 2016. I call your attention specifically criteria III.A.2. Lastly, I learned that in March 2014, ACGME announced commencing on July 1, 2015 to June 30, 2020, all AOA-accredited training programs will transition to ACGME recognition and accreditation.

In closing, I have over twenty-five years of experience serving in various roles within the academic community and know from those experiences that as a program director, you have the ability to waiver or set aside what I consider to be an artificial barrier. ACGME in its updated eligibility criteria gives you that latitude. Thus, I am strongly urging you to reconsider your position with regards to this candidate.
